- 3. Applicants should have at least three years of experience in supplying the relevant items/ services.
- 4. VAT Registration certificate or the VAT exemption certificate issued by the Commissioner General, Inland Revenue and a copy of the certificate should be attached.
- 5. Every supplier should agree to provide a credit facility for at least one month.
- 6. Applicants should submit a letter of request for Application for Registration of Suppliers and Contractors to the Director General, Industrial Technology Institute, and should clearly mention the relevant item/service. For further details, please call on **Tel No.011 2797314/15**
